Child Care Facilities Fund Deadline Extended

Deadline: Friday, January 14th

The Child Care Facilities Fund knows that you are working diligently on your application(s). We also understand that there have been covid related delays with obtaining comparable quotes. So, we are extending the application deadline until Friday, January 14, 2022, at 5 pm. All applications and supporting documents are to be submitted electronically to ecefacilityfund@phmc.org. Each requested project or purchase must have comparable quotes when submitted. The CCFF application, project budget template, and supporting document template are on our website. If you have already submitted your application, you should've received an email stating that we have received your application(s).

Organizational Eligibility

- Currently licensed STAR 3 or STAR 4 operator in Philadelphia
- Long-term commitment to providing high quality child care services

ELRC 18 Updates

Hi everyone,

I have lots of reminders and updates to share with you, so let's get right to it...

Base Rate Increase – As I hope you remember, the State increased the Maximum Child Care Reimbursement Rates (base rates) effective January 1st. You'll find a copy of the new maximums for Philadelphia County here: https://www.dropbox.com/s/npl4uu62r717mti/FYI%20-%20Maximum%20Child%20Care%20Rates%20-%201-1-2022.pdf?dl=0

- If your current private pay rates are higher than the new maximum, you do not need to do anything to receive the increase.
- All providers will receive an updated Appendix C2 (subsidy reimbursement rates) in the mail later this month.
- If you would like to update your private pay rates:
 - Do <u>not</u> worry about updating PELICAN Provider Self Service. It's just extra work for us both!
 - You must submit an updated Appendix C1 with a copy of your published rates (typically a flyer or page from your handbook used to inform the public about your fees).

 - If we receive your documents by 1/31/2022, the new rates will be effective 1/1/2022.

Non-Traditional Add-on – Also effective January 1st, a 25% increase over your base rate is being added for non-traditional care.

- Non-traditional hours are between 6p and 6a Monday through Friday, or anytime on Saturday/Sunday.
- The non-traditional add-on will be added for enrollments that have at least 2 hours of care during non-traditional hours during the week or anytime on the weekend.
- Enrollments that are eligible for the non-traditional add-on will show "NFT" or "NPT" on both your enrollment summary and attendance invoice.
- Please be sure to check any enrollments that you believe should be paid the non-traditional addon. If you do not see the non-traditional indicator, send an e-mail including the child's name and record number, along with the hours of care, to ELRC18providers@caringpeoplealliance.org.

Co-payment Decrease – On January 17th, many families will receive a decrease in their weekly co-payment as a result of the State's COVID relief efforts. Families and providers who are impacted will

receive an updated Enrollment Summary. You will also see the update reflected on your attendance invoice on PELICAN Provider Self Service.

Charging Fees Above Subsidy – If you currently charge subsidy families the difference between your private pay rate and what ELRC pays you, you MUST recalculate this amount effective January 1st and again January 17th if the parent receives a co-payment decrease. Remember that you must include your Keystone STARS add-on when calculating the fees above subsidy. If you have any questions or need help calculating this amount, please contact the provider services team, either at ELRC18providers@caringpeoplealliance.org or by calling (215) 382-4762 ext. 2980.

Full-time care of school-age children during virtual education – Per OCDEL, we cannot pay for full-time care of school-age children during their virtual education. There has been no change on this policy.

ARPA Stabilization Grant – ELRC 18 has approved 1,230 applications (82.27% of eligible providers in Philadelphia). The deadline to apply for the ARPA Stabilization Grant is 1/31/2022. If you have not yet applied, please be sure to at least access the application in the PD Registry and review the prepopulated information to make sure no data fixes are needed. - The State has not yet released information on reporting how you spent the grant. We will send it out right away when they do.

Keystone STAR Extensions – OCDEL has approved one year extensions of all STAR expirations from 10/1/2021 through 9/30/2022. For additional information, please contact your ELRC 18 quality coach.

PHLpreK, PreK Counts and Head Start – Hopefully, by now, if you provide subsidized wrap-around care to children enrolled in one of these programs, you have already submitted the appropriate enrollment verification form to ELRC. Reporting COVID Cases

Remember that OCDEL requires you to report all cases of COVID-19 in your program to both Certification and the Department of Public Health. In Philadelphia, the easiest way to do this is to use the following link: https://phillyhs.az1.qualtrics.com/jfe/form/SV_1NWgJ7yfK46dXMi

How to reflect COVID-related closures/absences on your CCW invoice

If you close due to COVID-19, do not enter closure (paid or unpaid) through PELICAN Provider Self Service. Instead, all COVID-related closures/absences should be recorded on your invoicing as follows. As long as you report as required (see above), ELRC can pay you for up to 14 consecutive business days of COVID-related closure or absence.

ONLINE:

Mark the children absent and enter the "COVID-related absence" comment by clicking on the hyperlink under each child's name. The comment is very important to make sure you are paid correctly and that the absences aren't counted toward the children's annual cap.

PAPER:

Mark the children absent using the code CA. This is very important to make sure you are paid correctly and that the absences aren't counted toward the children's annual cap.

Co-payments during COVID-related closure/absence

Please remember that subsidy co-payments are not to be collected when there is a full week of COVID-related absence or closure. Co-payments are not prorated, so if even one day of care is provided, the full co-payment is due. To provide guidance on the requirements of child care providers for child or facility person return to the child care facility after having a communicable disease, specifically COVID-19.
